RULES AND REGULATIONS
It is imperative that Parent/Guardian and Student
read and become familiar with the Rules and
Regulations,
and complete and return the attached release form.

Withdrawals and Refunds

A refund of 50% (less \$25.00 registration fee) will be made **ONLY** if withdrawal is made ***in writing*** at least three business days (Monday through Friday) prior to the first day of session in question.

Rules and Regulations

1. ALL students must register at the sign-in station (at the ticket window near the school entrance) or with a curbside attendant when entering and departing the building. ALL students must inform the Administration in the event they must leave the School before classes conclude.
2. The Majestic Theatre is on the National Register of Historic Places. Students should treat the facility with care and respect. Any damage to the building will not be tolerated and is grounds for dismissal from the school. The Majestic is also a working theatre; we occasionally must work around a show that is loading in or out.
3. Students may not stray from the confines of the Majestic Theatre, nor should they leave their classroom unless excused by their instructor. Majestic Theatre management strictly prohibits access to any other parts of the building other than classrooms, lobby, restrooms, school office and green room area, unless for a scheduled school event.
4. The School does not provide lunch. Please plan accordingly. Food and beverages will be confined to the school green room area and the Experimental Theatre. (See "Offsite Lunch Form".)
5. NO SMOKING is allowed in the Majestic Theatre. Students 7 to 18 years of age are not allowed to leave the building for smoking purposes.
6. Pianos and sound equipment are not to be touched other than by authorized personnel.
7. School phones may not be used without permission. Should students need to make a phone call, once they get permission, they may use the school office phones located in our offices on the third floor or the pay phones on the basement level and the balcony, third floor level. DO NOT ASK TO USE THE PHONE AT THE GUARDS STATION. Use is prohibited!
8. DSM School of Musical Theatre reserves the right to change the class level of a student during the workshop if teachers observe that a different level of instruction is more appropriate for the student.
9. Students should be on time for all classes. Please notify the School office in the event of tardiness or absence.

DRESS CODE

Musical theatre: tights, leotards, jazz pants, warm-up/sweat pants or long athletic pants are acceptable. No blue jeans or baggy clothing permitted during dance portion of class. During vocal section of class, students may slip on additional clothing over their dance attire.

Dance footwear: jazz oxfords, jazz boots, or ballet slippers are the best choice, but light-weight, flexible tennis shoes are acceptable. No chunky aerobic shoes, platform tennis shoes, hard soled shoes or boots allowed. Students need to point their feet!

Acting: jeans, comfortable pants.

In general: clean T-shirts, not ripped or torn. No inappropriate slogans or images please. We recommend a sweater or sweatshirt to slip on; our building can be quite cool.

Note: the staff/teachers may request that a student make a change in their attire for classes—clothing will vary from student to student, but a professional appearance is important.

The Dallas Summer Musicals Academy demands a high caliber of performance and personal behavior. Drugs, alcohol, abusive language or participation in activities not meeting the standards of the School will not be permitted.

These rules are made for the protection and well being of the students and to promote high ideals of character and professional behavior.

The Dallas Summer Musicals Academy pledges to provide the highest possible training in the field of musical theatre.

In return, we expect these policies to be honored and met.
